Siân Cwper at Caernarfon Crown Court

On a drizzly October day, Siân Cwper (pronounced 'Shaan Cooper') and a group of her supporters gathered outside Caernarfon County Court in northern Wales. Siân received an official summons to account for the fact that she withholds ten percent of her taxes, the proportion that is used by the government to finance the military

and to engage in the activities of war.

Siân has withheld this percentage of her taxes for the past five years, as a practicing Buddhist who has taken a vow not to kill or support killing, but this was the first time she was called into court to explain the reason for her tax liability.

Her hearing was delayed for awhile, and then she was told that the case had been withdrawn, as her back taxes had been paid.

It appears that when any current taxes are paid by residents of the United Kingdom, these funds are first applied to the balance due from earlier years. As a result, taxes withheld in the past as a matter of conscience are automatically paid using current revenue. But the total debt created by taking this action can continue to grow from one year to the next.

The Judge granted Siân a few minutes, privately in chambers, to make a statement. She explained that individuals have international duties of conscience which transcend national obligations of obedience, and that people have the duty to violate domestic laws in order to prevent crimes against peace and humanity.

And she added:

"Many people have said that I am brave. I would like to contradict this. I do not think that you, honourable judge, are a dangerous person. It is not impossible, even, that you sympathise with my stand.

Of course, I assume that you will order a sum of money to be taken out of my bank account. That is your job, and you have no choice. But I don't see that it takes much courage to stand here in front of you and face such a threat.

The truly brave people are those who oppose their governments, and stand up for justice in a long and heartbreaking list of places, where making such a stand means the threat of imprisonment, torture or death.

May the prayers that are focused on this case today be of benefit to such people everywhere."

The Judge said that he respected her views, but that he was in no position to change the law. Siân's full statement can be found on the Peace Tax Seven web site (<u>www.peacetaxseven.com</u>).

Siân was supported by many more people than those who traveled to be with her at Caernarfon on a rainy October day. She reports that she received messages from New Zealand, Japan, Spain, France and the United States. North American Quakers in the states of New York and Connecticut sent out an email to their membership, and to others around the world. This message explained how to contact Siân with a statement of support, and also provided the time of the court hearing so people could pause and hold her in their thoughts and prayers.

Siân may be summoned before a Judge again, and she hopes to explain, in public, that as a duty of conscience she is not able to voluntarily hand over money to the government that she knows will be used for killing.

CPTI Supporting Members will be informed in advance of the next court hearing, so that many more people can contribute to Siân's witness of conscience, in solidarity.
